

Legacy gifts may be directed in a number of ways including:

1. Provide an unrestricted gift that will be placed in the Sustaining Fund enabling the church to enhance ministries and properties beyond what is possible through annual operating funds.
2. Give a designated gift to the First Presbyterian Endowment Fund specifically for the Youth Minister position.
3. Augment an existing fund for a specific purpose or ministry.
4. Establish a new endowment through the Presbyterian Foundation.

Are There Additional Options for Making a Contribution?

Yes. Using one or more of the below alternatives can also help reduce your estate tax liability.

1. Life insurance policies
2. IRA's
3. Charitable gift annuities
4. Other retirement plans

The term 'legacy giving' defines the various ways a member can make a financial gift to the church, i.e., through their estate plan, life insurance policy or appreciated assets.

When was it Created?

Established February 6, 2011, it recognizes the

tireless efforts that Dr. Richard E. Neumann made during his 55 years of active ministry to the church.

How has the Neumann Society Impacted the Church?

The Neumann Society provides a strong foundation that continuously impacts our lives in numerous ways. Here are a few examples of how legacy giving lives on in our church:

1. Undesignated gifts provide ongoing support through the Sustaining Fund. Invested for growth, the gifts are used annually to support the ongoing needs of the church as determined by the Session.
2. Legacy gifts provide support for various ministries such as the Music Ministry and the Adult Activity Center.
3. Gifts have helped purchase and renovate The Harbor at the Hoch Youth Center.
4. Restricted gifts to The Endowment Fund for the Minister of Youth ensure support for youth and college students.
